# Pilot and Glider Certification Requirements

#### Please pay particular attention to cases below:

1) Non-US Licensed pilots flying US (N) registered gliders in US will need US Pilot Certificate conversion

2) Special Flight Authorization (US Airworthiness) requirement to certify any non US registered "Permit to Fly" or "Experimental gliders.

#### 3.6 INSURANCE

3.6.1 Third party insurance, as specified below, is the responsibility of the entering NAC.

Proof of insurance applicable to the registered sailplane and pilot(s), effective through the final scheduled competition day, showing coverage of at least one million dollars (\$1,000,000) per occurrence for bodily injury and property damage liability, with no reduction in coverage for persons outside the insured sailplane.

3.6.2 Personal medical insurance is required for all team members, covering accidents and sickness, including any local hospital costs and the costs of transport back to the team member's home country.

## Flarm Requirement

- 1. Flarm will be mandatory for the WGC2024 in Uvalde.
- 2. Flarm in the USA will operate on the ISM band of 915 MHz, flarm based on the GPS position, the Flarm will switch to the 915 MHz band when it detects that is in USA (ITU area 2)
- 3. A slight improvement will be to bring an antenna optimized for that frequency 915 MHz (versus EU 868 MHz or Australia 925 Mhz)
- 4. It is strongly recommended to check the Flarm using either the Flarm tools or the OGN/kisstech web tool <a href="https://ktrax.kisstech.ch/flarm-liverange">https://ktrax.kisstech.ch/flarm-liverange</a>
- 5. You will need to provide to the organizers at scrutiny time your **Flarm ID**, check <a href="http://wiki.glidernet.org/wiki:lookupflarmid">http://wiki.glidernet.org/wiki:lookupflarmid</a> for further details how to find it
